**Announcement of Appointment of Voluntary Administrator on 18 October 2017**

I advise that yesterday, 18 October 2017, the Directors resolved to appoint me, Peter Krejci of BRI Ferrier, as Voluntary Administrator of Prosperity Resources Limited ("the Company") pursuant to Section 436A of the Corporations Act 2001 ("the Act").

I understand that the Company has not trading for some time and was delisted from the ASX on 2 October 2017.

As Administrator, I am conducting investigations into the affairs of the Company and will report to creditors through the Voluntary Administration process. I note at this time that my initial enquiries indicate that the Company is clearly insolvent and has minimal assets, however it is unknown if there will be a return available for creditors or shareholders.

I note that within 25 business days a meeting will be convened at which creditors will be asked to resolve one of the following options in respect of the future of the Company:

- ▲ that the company execute a deed of company arrangement; or
- ▲ that the administration should end; or
- ▲ that the company be wound up.

Please note that as a consequence of the Voluntary Administration, and noting the Company's prior delisting from ASX, pursuant to Section 437F of the Act, no shareholdings can be transferred without consent of the Court or the Administrator. I note that such consent may only be provided where the transfer is in the best interest of the Company's creditors as a whole.
