A. DETAILS OF APPLICATION

This application is made under sections 596A, 596B and 597(9) of the *Corporations Act 2001* (Cth) and Rule 11.3 of the Federal Court (Corporations Rules).

2. An order that a summons addressed to the following persons be issued pursuant to s 596B of the *Corporations Act 2001* (Cth) and be returnable at Law Courts Building, Queens Square, Sydney on a date and time in April 2026 to be determined by the Court (noting an estimate of 1 day of examinations will be required):
 - a. Ye ('Eric') Qu; and
 - b. Ding Wang.
3. An order, pursuant to section 597(9) of the *Corporations Act 2001* (Cth) and rule 30.34 of the *Federal Court Rules 2011* (Cth), that the Court issue orders for production, in the forms exhibited to the Supporting Affidavit, to the following people (to be returnable at a date and time convenient to the Court, not less than 2 weeks before the date in orders 1 and 2):
 - a. Ye ('Eric') Qu;
 - b. Sheng Yin Wang; and
 - c. Ding Wang.
4. An order that the questions to be put to each person summonsed to attend before the examination and the answers given by such persons on such examination shall be recorded in writing and a copy of same shall be furnished to the plaintiffs by the Registrar of the Court.
5. An order that the persons summonsed to attend before the Court for examination, authenticate the transcripts in accordance with the provisions of the *Corporations Act 2001* (Cth), or in the alternative, sign the transcript of their respective examination pursuant to section 597(14) of the *Corporations Act 2001* (Cth).
6. An order that the costs of and incidental to this application be costs in the winding up of the Company.
7. Such further or other order as the Court deems appropriate.
