We refer to our previous correspondence and to the resumed second meeting of creditors of the Companies held on 6 January 2025.

At the meeting, creditors resolved to accept a Deed of Company Arrangement ("DOCA") in the form proposed. On 16 January 2025, the DOCA was executed.

The primary purpose of the DOCA is to provide a short holding period until the sale of the Hotel Australasia can be completed. As you will be aware, contracts for the sale were exchanged late last year and settlement is scheduled to occur in the first week of February 2025. We anticipate that upon completion of the sale, the Deed Administrators will convene a meeting of creditors, where we are likely to recommend creditors place the Companies into Liquidation.

We enclose a formal notice of the execution of the deed as required by the legislation.

Our records indicate that there are a substantial number of creditors who are yet to submit a claim. We encourage creditors who have not done so already to complete the attached proof of debt form and provide relevant supporting documentation.
