A. DETAILS OF APPLICATION

This application is made under sections 447A(1) and 461(1)(k) of the *Corporations Act 2001* (Cth) (**Corporations Act**), rule 1.8 of the *Federal Court (Corporations) Rules 2000* (Cth) (**Rules**) and section 37AF(1)(b)(i) and (iv) of the *Federal Court of Australia Act 1976* (Cth) (**Federal Court Act**).

This application is for orders that Union Standard International Group Pty Ltd (Administrators Appointed) ACN 117 658 349 (**Company**) be wound up on just and equitable grounds.

On the facts stated in the supporting affidavits, the Applicants seek:

1. An order pursuant to section 447A(1) of the Corporations Act that the administration of the Company is to end.
2. An order pursuant to section 461(1)(k) of the Corporations Act that the Company be wound up on the ground that it is just and equitable.
3. Peter Krejci and Andrew Cummins be appointed joint and several liquidators of the Company.
4. The requirements of section 5.6(1) of the Rules be dispensed with.

 - (a) the creditors of the Company, in the following manner:
 - (i) where the Applicants have an email address for a creditor, notifying each such creditor, via email, of the making of the orders and providing a link to a website where the creditor may download the orders and the Interlocutory Process;
 - (ii) where the Applicants do not have an email address for a creditor but have a postal address for that creditor, notifying each such creditor, via post, of the making of the orders and providing a link to a website where the creditor may download the orders and the Interlocutory Process; and
 - (iii) placing scanned, sealed copies of the orders and the Interlocutory Process on the website maintained by the Applicants for the purpose of making information available to creditors; and
 - (b) the Australian Securities and Investments Commission.
6. An order that the Applicants' costs of this application be costs in the administration of the Company.
7. An order that the Court's orders be entered forthwith.
8. Such further or other orders or directions as the Court considers appropriate.
